Our vision of AMP members rallying on Capitol Hill came to life this year during the AMP 2014 Annual Meeting in Washington, DC. More than 79 members gathered for conversations with nearly 100 offices on The Hill where we informed our decision makers at the national level of the valuable role of molecular diagnostics and the work that we do. I am incredibly proud of this initiative and the groundwork we've laid to help realize the dream of precision medicine.



This year's Annual Meeting also provided the platform for a standing room only session where AMP meeting attendees had the opportunity for Q&A with the FDA regarding laboratory developed procedure oversight and regulation. Members of the media were onsite for the session and joined us for a news conference immediately afterwards. 2014 was a busy year for AMP in the realm of public policy. Issuing 15 position statements and papers, AMP addressed issues such as:

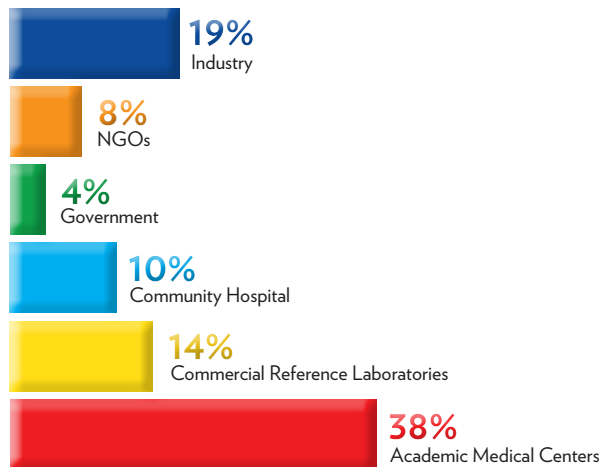

In April of 2014, AMP published its curriculum recommendations for medical laboratory scientists (MLS), including that up-and-coming molecular diagnostic laboratory scientists should complete an NAACLS accredited training program, then become certified or licensed in their state of employment.

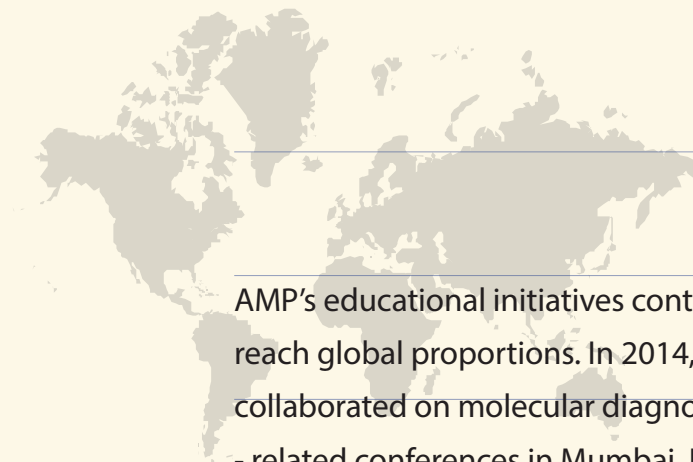
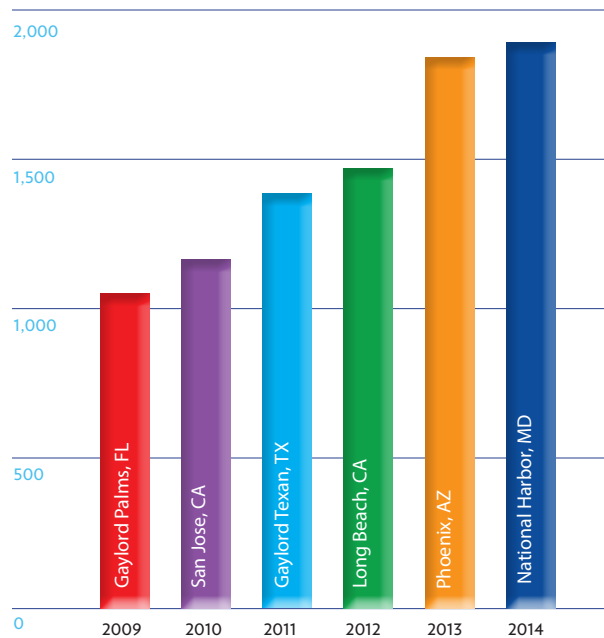
Membership and Annual Meeting

To help support emerging molecular pathology professionals from around the world, the Board reduced membership dues for all trainees and many regular members outside the U.S., beginning in 2014.

AMP ended the year with continued membership growth, rising from 2,162 in 2012 to 2,326 in 2013 and 2,339 in 2014. Indicators suggest that the growth will continue for the coming years.

The Annual Meeting also continued to grow with nearly 2,000 attendees in 2014. Also in attendance were nearly 200 exhibiting companies and their staff of roughly 1,300 individuals.
